## WHAT IS RECOVERY COURT?

Recovery Court is an alternative sentencing program for those with pending charges out of General Sessions or Criminal Court in Sumner County, who are non-violent offenders and that have substance use issues, an option to enter a voluntary, intensive, usually 2 year eqwt v/supervised recovery program. Participants undergo extensive treatment, both inpatient and outpatient, as well as weekly meetings with the Recovery Court Judges, reporting 3 times weekly for case management, 'y kj 'y kpgugf randomized drug testing. This rigorous structure and accountability k'y j cvbur graduates report when asked, what helped them succeed the most. Recovery Court is here to reducg'the harmful effects of drugs & alcohol on Sumner County0

## EXPECTED COMMUNITY BENEFITS

### LESS GOVERNMENT SPENDING

Alternative to Incarceration in county jail means that for every participant in the program, approx \$42.00/day to house an inmate is not being spent

### CONTRIBUTING TO SOCIETY

Working and paying taxes, contributing to their families, paying child support, being productive members of society contributing to their communities.

### REDUCED RECIDIVISM

Studies show the treatment court model significantly reduces recidivism (rearrest) rates as well as drug use among its participants.

## EXPECTED PARTICIPANT BENEFITS

### LIFE OF RECOVERY

Participant will be given the tools they need to lead a life free from mood altering substances through accountability, education, supervision, and treatment.

### ALTERNATIVE SENTENCING

Approval for Recovery Court is in lieu of incarceration.

### ENHANCED QUALITY OF LIFE

Participants will receive employment referrals and education options. They will have a support team committed to helping them become self sufficient, productive members of society
